CONTEST RULES (Please read carefully)

1. Contestant must be female, at least 18 years of age and MUST BE AFFILIATED with either a racing team, racing related organization, product, or vendor, but not already currently under monetary contract, or acting as Queen or Model for any sponsor or product. NO PAID MODELS APPLICATIONS WILL BE ACCEPTED. All applications must be accompanied with proof of age (i.e. Drivers License), and current photograph, preferably candid shot.
2. Contestants must report to the show office between 5:00-6:00 p.m. to prepare for the event on Saturday, February 4th for the 7:00 p.m.
3. Ms. Racing Xtravaganza 2018 winner must be available for all show activities on Saturday, February 3rd, Sunday February 3rd, 2018 and must be present at contest in 2019. She will also be required to attend a minimum of ten-(10) racing events in which 5 will be scheduled shows and 5 of her choice at various speedways in 2018. PLEASE BE AWARE THAT THIS IS MANDATORY AND YOU ARE SIGNING A CONTRACT TO COMPLETE THESE TASKS IF CHOSEN AS THE WINNER.
4. Contest will include interview and photo sessions. Sportswear round, like you might wear to the race track as a trophy presenter, and the final formal wear round, dresses or dress pants are acceptable. No skimpy swim wear, bikinis, or thongs of any kind will be permitted. Judges are looking for a fun-loving, reliable lady to represent the Central PA Racing Xtravaganza show for the year. Judges are instructed to value poise, presence, enthusiasm, racing knowledge and attractiveness equally.
5. Ms. Racing Xtravaganza 2018 winner will receive a sash, tiara, jacket, and \$1000.00. Second place will receive \$400.00; third place - \$175.00.
6. Racing Xtravaganza management reserves the right to disqualify any applicant for nonconformity to the above rules. Ms. Racing Xtravaganza 2018 may also be required to relinquish title due to unbecoming behavior, or the inability to fulfill title duties as deemed by same show management. Should title be revoked, winner will be required to return winner's monies, sash and tiara. A replacement will then be sought to fulfill tenure from contestants starting with first runner-up.
